**INSTRUCTIONS:**  
**SPOT-TREATMENTS** — Mix AQUA-ZORB® CA with the ORNAMEC® OVER-THE-TOP GRASS HERBICIDE and water solution according to the amount shown in the chart below. Spray to obtain thorough coverage. Re-treat if necessary. See ORNAMEC® labeling.

For This Spray Volume	Use This Amount AQUA-ZORB® CA
1 gal.	1/8 fl. oz.
10 gal.	3 fl. oz.
12 gal.	4 fl. oz.

**BROADCAST TREATMENTS** — Use 4 fluid ounces (fl. oz.) AQUA-ZORB® CA per 12 gallons of ORNAMEC® spray solution. See ORNAMEC® labeling.
