Umrah Terms & Agreement

Reservation, Deposit and Cancellations Policies:

- Deposit of \$300 pp at time of booking to reserve Hotel and start visa process.
- Airline tickets must be paid in full at time of issue (Some Airline Tickets are Not refundable, penalty will apply if the tickets are refundable plus \$100.00 administration fee).
- Full payment due 4 weeks prior to departure.
- Cancellations must be received in writing.
- Cancellations of land & hotels packages 30 days prior or more to departure are subject to a 30% penalty from the land & hotels total price, in addition to \$200 pp administration fee will apply.
- If the cancellation occurred between 10-30 days prior to departure 50% from the total land & hotels price in addition to \$200 pp administration fee will apply. If the cancellation occurred within 10 days prior to departure, NO REFUND.
- Unused visas are subject of a \$300 administration fee pp.
- No visas are issued for packages that are staying longer than 1 month.
- Accidental or intentional overstay of more than 30 days in KSA is subject to a penalty of \$1500 pp.
- For bookings made within 4 weeks prior to departure Full price of the package selected is due immediately upon booking.

• Documents Required:

- Valid passport for at least six months with 4 empty pages.
- Two passport size photos (white background).
- Permanent residents, please submit copy of your green card.
- Original certificate of Vaccination for Meningitis.
- Any supporting documents required by the Saudi Embassy must be notarized.
- Females over 45 travelling without a Mahram must have notarized letter of no objection.
- Females of any age travelling with a Mahram must have proof of relation.
- Females under 45 may cannot travel without a Mahram.

Responsibility & Liability:
